COURSE OUTLINE

Synopsis:

The course assists students in defining a research project and designing appropriate methods, objectives and measures. Course material addresses methods of data acquisition, analysis and interpretation for research in architecture.

Content and Organization:

This is a seminar course that meets once a week. It will be open to all graduate level students, but is required of the MAA and History Certificate cohort and advanced undergraduates with permission of the Chair.

Requirements:

Regular attendance is mandatory and active participation in discussions is required. Short papers and questions to facilitate class discussion are required.
